Documentation to submit with this application:

ALL applicants must submit the following:

- Letter or preprinted form from Commanding Officer or other appropriate official verifying service in the Georgia National Guard or the U.S. Military Reserves.
- Presentation of military ID card (must be presented in person – no copies may be accepted)
- Copy of orders
- Copy of Enlisted Record Brief (ERB)

Applying based on a PARENT (students under the age of 24 only) also include one of the following:

- Copy of birth certificate for the student listing the service member as a parent;
- Copy of the DD1172 (DEERS form) for the service member listing the student as a dependent;
- Copy of the federal income tax return filed by the service member for the most recent tax year and listing the student as a dependent child; or
- Presentation of the dependent military ID for the student (must be presented in person-no copies).

Applying based on a U.S. Court-Appointed LEGAL GUARDIAN (students under the age of 24 only) also include one of the following:

- Copy of U.S. court documentation listing the service member as the guardian of the student;
- Copy of the DD1172 (DEERS form) for the service member listing the student as dependent;
- Copy of the federal income tax return filed by the service member for the most recent tax year and listing the student as a dependent child; or
- Presentation of the dependent military ID for the student (must be presented in person-no copies).

Applying based on a SPOUSE also include one of the following:

- Copy of the marriage certificate for the service member and the student; or
- Copy of a jointly filed federal income tax return filed by the service member for the most recent tax year listing the student as a spouse. Or, copy of a jointly filed federal income tax return filed by the student for the most recent tax year listing the military member as a spouse.

I understand that any material false statement made knowingly and willingly by me on this application, or any documents attached hereto may, in accordance with O.C.G.A 16-10-71, which provides that upon conviction, a person who knowingly commits the offense of false swearing shall be punished by a fine of not more than \$1,000 or by imprisonment for not less than one nor more than five years, or both, subject me to prosecution in a court of law. Additionally, I further understand that any such false statement may subject me to immediate dismissal from the institution. I certify that, to the best of my knowledge, the information submitted on this application is true and complete.
