The Dynamic Security Officer (Sherry Miller) contacted the Floyd County EMS, EMS arrived on campus and examined Jesse's finger and offered to transport him to the Floyd County Medical Center. Jesse refused to be transported to Floyd County Medical Center and contacted his aunt. Jesse's aunt arrived on campus and transported Jesse to Floyd County Medical Center.

Kristy stated she met Emily during the Spring Semester of 2017 in a library (Study Room) on the Cartersville Campus. Kristy stated she introduced herself to Emily and Emily told her "I was beautiful and she loved me". Kristy saw Emily again during the Summer Semester at a "Safe Zone" training and the two exchanged phone numbers. Kristy did not see Emily again until the Fall Semester of 2017 and Emily's behavior towards Kristy became progressively alarming. Emily started showing up everywhere Kristy was on the Cartersville Campus and she was in Kristy's Forensics Class and was upset Kristy did not sit next to her. Kristy started hiding in the library to avoid Emily, Kristy stated Emily started texting her frequently just saying "Hey" or "Hey girl" and she felt Emily was waiting for her after her Psychology Class with Professor Dose. Kristy stated she told Professor Dose about what was going on and Professor Dose recommended Kristy speak with security regarding this matter. Kristy stated Emily's phone number is 678-896-6427 and she still has some of the text messages from Emily.

Notes: On 11/28/2017 at approximately 0840 Hours, Billie Saenz (GHC Douglasville Campus Administrative Assistant) stated that she observed two GHC Douglasville Campus Students (Chelsy Ramos/GHC ID: 900142910 and Orbin Noe Tercero/GHC ID: 900145692) involved in a verbal dispute while walking near the administrative corridor. She stated that they both were using inappropriate words (Profanity) which they directed at one another. She asked them to stop using foul language while on campus but they continued. She then stated Chelsy Ramos said that Orbin Linares had removed her car keys from her purse and refused to give them back and that he responded by saying he was going home for the day. She stated that she then asked him not to leave or she will tell the police that he left. Mrs. Saenz then asked the campus security officer (Jasmine Smith/Dynamic Security) to Dial 911 and to notify this officer (Sgt. Grant, R) which she did. The two involved students stood by and waited for the arrival of Douglasville Police (Officer Walker, Unit 248) who arrived within 5 minutes of being called.
