Upon arriving home at approximately 1500 Hours, she stated that after exiting the vehicle she noticed that her vehicle had been struck (Side Swiped) on the Left Lower Passenger Side Doors that resulted in moderate black colored scratch and dent marks to her vehicle. The only information available on the other vehicle (Vehicle 1) was that it was dark colored (Possibly Black). There is no information available on the driver. The Driver of Vehicle 2, also said that she was certain this Hit & Run Accident" occurred on campus and that she was sorry she didn't see the damages to her vehicle prior to leaving campus. A review of the campus video and camera system did not show how or when this incident occurred (Vehicle 1, and Vehicle 2 out of Camera Range).
