## **Borrow Responsibly – Things to Know About Defaulting on Student Loans**

- You will NO longer be eligible for Federal Student Aid.
- You may lose your tax refund(s) to repay your defaulted loan(s).
- Wages may be withheld by the federal government to repay your defaulted loan(s).
- Additional interest rates will be added to your balance along with late/past due charges.
- Any professional license may be denied or revoked due to your defaulted loan(s). •
- Defaulted loan(s) will appear your credit score for at least 7 years.
- Know your servicer/lender contact information and when your loan(s) will become due.
- Know what repayment options you may have by talking to your servicer/lender.
- Monitor your loan information at nslds.ed.gov.
